

PROPOSAL 4: Defines Corporate Membership, rules and fees.

BY-LAWS OF THE CLARKSTON GOLF & COUNTRY CLUB, INC.

C. Business/Corporate Membership

**1. Certificate purchase, *Fees and Dues* - See Appendix A An initiation fee to be determined from time to time by the Board of Directors (*See Appendix A*). *The Business/Corporation will designate one person to be named on the Certificate and to vote at Club meetings. No others under this membership type may vote. The Business/Corporation is entitled to schedule meetings or events in the dining room or lounge provided those events do not conflict with a previously scheduled Club event. No set-up fees required. Reciprocal Golfing privileges with other Golf Clubs are not applicable.***

**2. *A Business/Corporate Membership entitles the Business to designate two types of Club participants – a Manager/Sales Team (Key Personnel) participant and a Business/Corporation Employee participant.***

***a. Managers/Sales Team (Key Personnel) members. Dues and Fees: See Appendix A. This entitles the Business/Corporation to gain designated management/salespeople full access to the Club facilities and the Golf course under the same rules as a Certificate Member as set forth in these by-laws but with exceptions, qualifications and additions as noted here-in for Business/Corporate Memberships. The Business/Corporation may elect to have the Club bill them directly for any charges incurred by their designated Key Personnel members or the Club will bill each designated member individually. The Business/Corporation may change, add, or delete Key Personnel designated members on an annual basis by written notice to the Club. Membership changes and additions are subject to Board Approval. Should any Key Personnel designated member leave the employment of the Business/Corporation, the Club must be notified in writing to cancel their membership or the corporation will be responsible for their fees until notification is received.***

PROPOSAL 4: Defines Corporate Membership, rules and fees.

***b. Business/ Corporation Employee: The Business/Corporation may also designate any number of employees to be golfing or social members, subject to Board approval and the criteria contained in these by-laws. The employees designated as golf members will be entitled to full use of the Club facilities and the golf course under the same rules and exceptions which apply to the types of memberships defined in these by-laws. The designated social members will be entitled to the full use of the Club facilities under the same rules as a social member. In addition to the monthly dues a minimum dining charge, as determined by the Board of Directors (See Appendix A) will be added.***

***3. Included with the Business/Corporate membership is a plaque to be hung in the Clubhouse. Also, a Business/Corporation that designates over five (5) members will receive a banner ad on the Club Website. A Business/Corporation that designates over fifteen (15) members will be designated a sponsor for Men's Opening/Closing and Couples' Opening/Closing golf tournaments. Signage/Promotional items will be allowed for these events.***

***4. Should the Business/Corporation resign its membership, the Club is under no obligation to repurchase or resell their certificate for any amount. The Business/Corporation may sell their certificate to another business or successor (subject to Board approval).***
